IMPOSTOR/WARNING

BECKY A. SANDEFUR: Becky A. Sandefur applied for employment with a doctor's office in San Antonio, Texas, and worked as an Administrative Office Manager from April 5, 2001 through April 19, 2001. Ms. Sandefur signed RN after her name on a cover-letter that she submitted to the doctor. Ms. Sandefur also included a resume on which she indicates that she is an RN, MSN. Ms. Sandefur was terminated from employment after the doctor's office was unable to verify licensure and Ms. Sandefur admitted that she was not licensed.

JERRY GRANT MITCHELL: Jerry Grant Mitchell worked as a registered nurse in the position of Clinical Case Manager and Advanced Practice Nurse, at a hospital in the Dallas, Texas area, from November 8, 1999 to April 27, 2001. Mr. Mitchell did not hold a license to practice in the State of Texas and his license in the state of Tennessee had been revoked in 1995. The hospital police referred the case to the district attorney's office in Dallas County and they are pursing criminal charges.

STEPHANIE A. WATSON: Stephanie A. Watson was employed by a school district as a nurses aide from September 2000 through May 2001. During her employment, she represented herself as a registered nurse and a Family Nurse Practitioner, and used the abbreviations RN and FNP after her name on letters to parents. Ms. Watson has never been licensed as a registered nurse in any jurisdiction. Ms. Watson is a student enrolled in a nursing program.

SHERRILL L. NEVINS a.k.a. SHERI LYNN COON: Sheri Lynn Coon applied for a position as a registered nurse in the operating room at a hospital in Hereford, Texas on February 20, 2001. Ms. Coon was instructed to appear on March 12, 2001 for license verification and salary negotiation, however she did not show up. The facility had gotten an anonymous phone call from a male informing them that Ms. Coon was not a registered nurse. The facility contacted the university listed in the employment application and verified that Ms. Coon did not have a degree in nursing. The facility tried verifying a license number provided by Ms. Coon and it did not match, therefore she was not hired.

STEVEN MEYER: Steven Meyer applied for an LVN position at a hospital in Austin, Texas and was hired on February 19, 2001. Mr. Meyer was asked to bring his license in for verification and he presented a registered nurse license which had been tampered with. The staff member verifying the license called the LVN Board and was informed that the number on the license was not one of their numbers. The license presented by Mr. Meyer read "Board of Nurse Examiners" at the top and the staff member verifying the license stated it was a registered nurse license. Mr. Meyer was terminated on March 6, 2001, for presenting a false license. The case has been referred to the Travis County District Attorney's office.

RONALD CHAIRES: Ronald Chaires worked as a clinical assistant in the ICU of a hospital in Austin, Texas, for three years. Mr. Chaires then told his supervisor that he would graduate with an Associate Degree in Nursing from Austin Community College in December 2000 and wanted to work as a Graduate Nurse. Mr. Chaires applied and was hired as a Graduate Nurse with a start date of January 15, 2001. Mr. Chaires was required to bring a letter from the Board of Nurse Examiners office verifying his graduate nurse permit. On March 2, 2001 Mr. Chaires was told to go to the Board office and bring a letter, he told them that he could not take the licensure examination because the nursing school messed up on some of his credits. The Clinical Manager called the school and was told that Mr. Chaires was not graduating in December 2000. On March 8, 2001, the supervisor met with Mr. Chaires and he admitted to the falsification, he was terminated from employment. The case was referred to the Travis County District Attorney's office.

IMPOSTOR/WARNING

TAMMY RENE CARNES

Tammy Rene Carnes applied for a position as a Registered Nurse with an Ob/Gyn physician's group in Houston, Texas on November 29, 2001. On December 3, 2001, the supervisor contacted the Board office to verify that Ms. Carnes had initiated the reciprocity process. She was told that no application had been received. The supervisor also contacted the California Board to verify licensure and was informed that Ms. Carnes has never held a license to practice in California. Ms. Carnes was not offered a position and the supervisor reported the information to the Board. The information regarding Ms. Carnes was referred to the Houston Police Department.

BRENDAL CHRISTENEE KRAMER a.k.a.: Brenda Christene Kramer

Brendal Christenee Kramer secured employment as a Scheduling Coordinator, with a hospital in Fort Worth, Texas on May 13, 2001. The position was an RN management position and required an RN license. Ms. Kramer told the facility that she was in the process of getting a Texas license and she claimed to have a current Tennessee license. The facility contacted the Board office after the supervisor became suspicious and began to question Ms. Kramer's credentials. The facility also contacted the Tennessee Board and found that Ms. Kramer has never been licensed to practice in the state of Tennessee. Ms. Kramer was terminated from employment on October 5, 2001 and a report was sent to the Board office. The information regarding the case was sent to the Fort Worth Police Department.

TAMERA BOYD

Tamera Boyd secured employment as a Registered Nurse in January 2001, with an imaging and pain management center in Fort Worth, Texas. Ms. Boyd signed RN after her name and told her employer that she had received a Bachelor Degree in Nursing. The employer contacted the university and was not able to verify that Ms. Boyd graduated from a nursing program. The employer asked Ms. Boyd to bring in her license for verification and Ms. Boyd failed to do so. The company contacted the Board office to verify licensure and they were informed that Ms. Boyd is not licensed in Texas. Ms. Boyd was terminated from employment on March 5, 2001. The information regarding this case was referred to the Fort Worth Police Department.

ROSE DIANE LEGG

Rose Dianne Legg was hired as a certified nurses aide by a nursing home in Friendswood, Texas. Two months after being hired she told the Director of Nursing that she had finished her nursing program and was now a registered nurse. Ms. Legg started signing RN after her name on some of the patients' medical records from October 2000 through December 2000. During a survey visit it was discovered that Ms. Legg was employed and signing RN after her name, however did not have a license to practice in the state of Texas. Ms. Legg had provided an RN license number belonging to someone else. The facility contacted the Board office and they were unable to verify licensure. The facility submitted a report to the Board.

CAROL J. GOFF

Carol J. Goff was employed as a Phlebotomist and Paternity Representative with a laboratory in Austin, Texas. Ms. Goff held herself out as a Registered Nurse to clients and presented business cards with RN after her name. Her duties include drawing blood from inmates for paternity testing.

Heather A. Cannatella

Heather A. Cannatella secured employment as a registered nurse with a staffing agency in Tyler, Texas. Ms. Cannatella was assigned to staff at a hospital and worked one shift (7p-7A) on January 15, 2002. The agency found out that Ms. Cannatella was not licensed to practice professional nursing in the State of Texas and terminated her employment. Ms. Cannatella also applied for a position as a registered nurse with a home health agency in Jacksonville, Texas; however they were not able to verify licensure and did not hire her. The information regarding Ms. Cannatella was referred to the Smith County District Attorney's Office.

Margaret Robinson a.k.a.: Margaret Bethel

Margaret Robinson secured employment as a registered nurse with several physician groups and physicians' offices during a period of time from January 1999 through February 2002. Ms. Robinson also applied for a position with a pediatric group and while they were checking the information on her resume they found that she was not licensed in Texas and has not graduated from a nursing program. The staff contacted the Board office and verified that Ms. Robinson was not licensed to practice professional nursing in the State of Texas. They contacted previous employers to verify the positions held and found that she had worked as a registered nurse since 1999. The information regarding Ms. Robinson was referred to the Collin County District Attorney's office.

Rebecca A. Sandifur a.k.a.: Becky Ann Sandefur

Rebecca A. Sandifur secured employment as a Billing Supervisor for a cardiovascular clinic in San Antonio, Texas on May 15, 2002. On her employment application, she indicated that she graduated from nursing school and had held past clinical and administrative positions in the capacity of a Registered Nurse. In addition, Ms. Sandifur used "R.N." after her name on the resume she provided to the clinic. The clinic decided to verify her credentials and learned that she had never been a Registered Nurse in the State of Texas. She was terminated on May 22, 2002 for falsification of information provided on her employment application. The information regarding the case was sent to the Bexar County District Attorney's Office.
