The mission of the Board of Nurse Examiners for the State of Texas is to protect and promote the welfare of the people of Texas by ensuring that each person holding a license as a nurse in the State of Texas is competent to practice safely. The Board fulfills its mission through the regulation of the practice of nursing and the approval of nursing education programs. This mission, derived from the Nursing Practice Act, supersedes the interest of any individual, the nursing profession, or any special interest group.



BNE Seeks Increased Criminal Background Checks

The Board of Nurse Examiners (BNE) submitted its funding request (Legislative Appropriations Request or LAR) for the 79th Legislative Session to the Legislative Budget Board for consideration in the upcoming Texas Legislative Session beginning January 11th and ending May 30, 2005. Funding for agency operations is tied to the following core strategies: Licensing, Approval of Schools, Adjudication of Violations and the Texas Peer Assistance Program for Nurses. The LAR is preceded by the BNE Strategic Plan for Fiscal Years 2005-09 submitted on June 18, 2004. The Strategic Plan included an assessment of issues by agency staff requiring additional funding, legislative rule making, or a combination of both. The Board determined that implementation of additional criminal background checks authorized by passage of HB 2208 in the 78th Regular Texas Legislative Session is vital to accomplishing the mission of the agency to protect the public from unsafe nursing practice. The legislature has required that all individuals seeking to obtain or retain a Texas nursing license possess “good professional character”; therefore, the criminal conduct of nurses and those applying to be licensed must be reviewed. House Bill 2208 (Allen), effective September 1, 2003, authorized implementation of criminal background checks for candidates for nurse licensure by endorsement (originally licensed in another state) or examination (nursing program graduates.) The BNE has conducted more than 10,000 background checks on candidates for licensure since passage of HB 2208. Since implementation, more than 950 candidates had criminal conduct requiring further examination by BNE Enforcement Department staff. In the next biennium, the BNE is seeking funding to include background checks on current licensees as well as candidates for vocational nurse licensure.

Additional items requested for the upcoming session include increased funding for the Texas Peer Assistance Program for Nurses, which has not seen a funding increase since 1997, and restoration of the five percent reduction requested of all state agencies for the FY 06-07 biennium. The *Texas Board of Nursing Bulletin* will inform readers in the event that funding is authorized to implement additional background checks.

Self-Help Resources Added for BNE Web Site Users

Several new sections have been added to the BNE web site to assist those seeking information on *Nurse Education* and *Advanced Practice Nursing*. The new web site sections added by the Nursing Practice and Education Departments makes helpful information readily available to all nurses, candidates for nurse licensure, and those seeking advanced practice credentials. Governor Appoints George Buchenau, Jr., to BNE



Governor Rick Perry announced the appointment of George Buchenau, Jr., BSN, RN, MBA, to the Texas Board of Nurse Examiners (BNE) on November 9, 2004. Mr. Buchenau is a registered nurse from Amarillo employed as executive director of a home health care agency. Mr. Buchenau represents Nursing Practice, replacing Thomas Barton, MSN, RN, who resigned from the BNE. Mr. Buchenau’s term on the Board expires January 31, 2009.

BNE Advisory Committee Updates

ADVISORY COMMITTEE ON EDUCATION (ACE)

At the April 2004 meeting, the Board issued a charge to ACE to draft new rule language related to nursing education. ACE met in August 2004 and proposed keeping vocational nursing education in a separate rule from professional nursing education. The committee drafted Rule 214, *Vocational Nursing Education* using some language from current Rules 215 and 233 and adding new language. During this review of the rules, minor changes were made to the current Rule 215 (Professional Nursing Education) and a new rule was proposed. Both rules were placed in the *Texas Register* for a thirty-day comment period, which ended December 13. A new chapter 215 was adopted and chapter 214 was presented at the January 2005 Board Meeting and adopted by the Board.

APN ADVISORY COMMITTEE (APNAC)

The Advanced Practice Nursing Advisory Committee (APNAC) met in Austin on October 27, 2004 to continue working on their current charges from the Board. They discussed the proposed amendments to Rules 221.2 and 221.7 (published in the August 13, 2004 edition of the *Texas Register*) that seek to limit the number of advanced practice titles the Board recognizes, and the public hearing related to the proposed rules held on October 20, 2004. The committee continued discussion of issues related to the advanced practice nurse's scope of practice and expansion of that scope of practice. The committee is scheduled to meet again in March 2005.

State of Virginia Joins Nurse Licensure Compact New Jersey Governor Signs Bill

The State of Virginia implemented the Nurse Licensure Compact effective January 1, 2005, becoming the 19th state to join the Compact. The Governor for New Jersey signed the bill enacting the Nurse Licensure Compact, but the implementation date for New Jersey has not been determined yet. The states that have implemented the Nurse Licensure Compact include: *Arizona, Arkansas, Delaware, Idaho, Iowa, Maine, Maryland, Mississippi, Nebraska, New Mexico, North Carolina, North Dakota, South Dakota, Tennessee, Texas, Utah, Virginia and Wisconsin*. Summary of Actions

A Regular meeting of the Board of Nurse Examiners was held October 21-22, 2004 in Austin. The following is a summary of Board actions taken during this meeting.



The following proposed rule changes were published in the November 12, 2004, issue of the *Texas Register*.

The Board of Nurse Examiners proposed the adoption of new chapter 214, §§214.1 - 214.13, concerning Vocational Nursing Education and new chapter 215, §§215.1 - 215.13 (Professional Nursing Education), of 22 Texas Administrative Code. Concurrent with these proposed adoptions was the proposed repeal of chapter 233 (Education) which addressed vocational nursing education and chapter 215 (Nurse Education) which is applicable to professional nursing education.

No comments were received in response to these proposed rule changes. Chapter 215 was adopted and Chapter 214 was presented for adoption at the January 2005 Board Meeting and adopted. NURSES HAVE THE OPPORTUNITY TO HELP DEVELOP THE NCLEX® EXAMINATION

The National Council of State Boards of Nursing (NCSBN) is responsible for developing the NCLEX-RN® and NCLEX-PN® licensing examinations by utilizing contributions from nurse clinicians and educators. NCSBN encourages all nurses to become involved in the development of the exams by participating in the item (question) development program. Qualifications for participation are listed below.

Serving on an NCLEX® item writing or review panel is an excellent opportunity to network with nurses from across the country, contribute to continuing excellence in nursing practice, and build new skills that are useful for professional growth.

Item development sessions are held throughout the year and include the item writing and item review panels. Item writing panelists are responsible for creating new test items that may later appear on one of the exams. Item review panelists examine both newly created and older items to help decide if the items are current and relevant to entry-level nursing practice.

All item development panels are held in Chicago, Illinois, and generally last 3-4 consecutive days. Panelists stay downtown in a deluxe hotel surrounded by the shopping and theater districts. Most travel and food expenses are covered and new panelists receive more than 30 CEUs for their participation.

New Interpretive Guideline for LVN Scope of Practice Established in §217.11

The passage of HB 1483 [78 Tex. Legis. Session, 2003] consolidated all licensed nurses under one regulatory board, thus pulling vocational nurses under the authority of the Nursing Practice Act (NPA) on February 1, 2004. Since then, the Board has combined and revised the two sets of rules that formerly existed for both agencies into one set of rules that applies uniform rule language across all levels of nursing licensure, thereby providing consistent regulatory guidance to all nurses in Texas.

The main rule applicable to nursing practice is Rule 217.11, Standards of Nursing Practice. This revised and combined Standards Rule became effective 9/28/2004. Rule 217.11 provides the framework for the minimum acceptable standards of nursing practice, and serves for determining a nurse's scope of practice. While the majority of the standards apply to all levels of nurse licensure, specific standards address each respective licensure level.

The purpose of this interpretive guideline is to promote understanding by vocational nurses and others of the accurate application of the Standards of Nursing Practice across all practice settings. The guideline also provides additional information through definitions, clarification of scope of practice parameters, and a table differentiating the scope of practice for LVNs and RNs. Interpretive Guideline for Differentiating Vocational Nurse Scope of Practice Under Rule 217.11 Standards of Nursing Practice - October 2004

Purpose:

Rule 217.11 establishes a foundation of minimum standards of nursing practice applicable across all levels of nursing licensure (inclusive of licensed vocational nurses, registered nurses, and registered nurses with advanced practice authorization in a given role and specialty). This guideline includes comparison between LVN and RN practice, and does not specifically address RNs and advanced practice RNs.

Background:

In February 2004, the integrated Board implemented an ongoing review of all BNE and BVNE rules to ensure congruency with the Nursing Practice Act (NPA). The Nursing Practice Advisory Committee [NPAC] assisted in the review of rules relating to nursing practice. The NPAC is one of the Board's three standing advisory committees and consists of interested stakeholders from nursing practice, nursing specialty and healthcare facility organizations, and relevant state agencies. At the first combined single-board of nursing meeting in April 2004, the Board charged the NPAC to review rules pertaining to standards of practice and unprofessional conduct for LVNs, RNs, and advanced practice nurses (APNs). Two resources were utilized by NPAC in developing the new standards: (1) the *Model Rules* from the National Council of State Boards of Nursing (NCSBN) [adopted by NCSBN, August 2004], and (2) the *Differentiated Entry Level Competencies of Graduates of Texas Nursing Programs (DELIC)*, September 2002. The model rules provided a national perspective on scope of practice parameters for the differing levels of licensure. The Model Rules may be viewed on the National Council's web page at www.ncsbn.org. The DELIC may be viewed in its entirety from the BNE's web page, www.bne.state.tx.us, under "Education." NPAC recommendations were presented to the Board at the July 2004 meeting. The Board approved NPAC's recommendations and proposed new rules 217.11 (*Standards of Nursing Practice*) and 217.12 (*Unprofessional Conduct*). These two new rules became effective September 28, 2004. Rule 217.11 provides the framework for the minimum acceptable standards of nursing practice, and serves for determining a nurse's scope of practice*. While the majority of the rule's standards apply to all levels of nurse licensure, there are specific standards addressing each respective level of licensure (LVN, RN) and advanced practice nursing. (*Note: Chapter 221, §§221.12 and 221.13 set forth additional guidance for scope of practice for APNs).

Definitions of Key Terms Used in 217.11(2) Standards Specific to Vocational Nurses

Some of the following terms may require further clarification in order to accurately apply and/or comply with the rule:

1) *Supervision*:

This term is defined in §217.11(2) as the "process of directing, guiding, and influencing the outcome of an individual's performance of an activity." Since §217.11(2) requires the LVN to function "under the supervision," this precludes the LVN from functioning in a completely independent (without supervision) manner. However, direct (on-site or on-unit) supervision is not required by the rule. The LVN must have a resource person accessible at least telephonically or by some other similar means. Proximity to the LVN's practice setting and the level of licensure of a supervisor (RN, MD, etc.) must be determined by the LVN and his/her supervisor on a case-by-case basis and in accordance with any other laws that are applicable in the practice setting.

2) *Healthcare Setting*:

In the *Differentiated Entry Level Competencies (DELIC)*, the term "structured healthcare setting" is used to help describe appropriate practice settings for entry-level LVNs; however, the NPAC committee agreed that the adjective "structured" could be misinterpreted and cause inappropriate restrictions on overall practice settings for LVNs in Texas. "Healthcare settings" is a term used to broadly define practice settings where LVNs routinely practice. Nevertheless, the DELIC definitions of "structured" and "unstructured" are instructive in defining the appropriate healthcare settings for LVN practice. A "structured" setting is defined by DELIC as "a geographical and/or situational environment where the policies, procedures, and protocols for provision of healthcare are established and in which there is recourse to assistance and support from the full scope of nursing expertise." The DELIC also states that the LVN is educationally prepared to deliver nursing care in "health care settings for individual clients who are experiencing common, well-defined health problems with predictable outcomes." By way of example, a healthcare practice setting for a LVN may also include a setting where continuous nursing services are provided (such as a nursing home, hospital, rehabilitation center, skilled nursing facility, clinic, or private practice physician office), or where the LVN has access to the licensed healthcare provider serving as the LVN's supervisor (such as home care, hospice, assisted living facility, group homes,

etc.). [Definitions taken in part from BNE rules §224.1 and §225.4(9).] In contrast to the above, a setting that is likely inappropriate for a LVN is an “unstructured setting” defined in DELC as “a geographical and/or situational environment which may not have established policies, procedures, and protocols and which has the potential of variations requiring independent nursing decisions.”

3) *Focused Assessment vs. Comprehensive (or RN Nursing) Assessment:*

The first step in the nursing process--assessment--is the basis for nursing decisions and interventions. The terms “directed” scope of practice and “focused” assessment for LVNs were extracted from Model Rule language subsequently adopted by the National Council of State Boards of Nursing (NCSBN) in August 2004. The NCSBN felt that while both LVNs and RNs “assess,” the depth, breadth, and comprehensiveness of the assessments conducted by the two levels of licensed nurses differ. Part of the basis for the definitions and descriptors used in the model rules evolved from a national job analyses of both LVNs and RNs. [217.11(2)(A)(i)] Licensed vocational nurses (LVNs) “conduct focused nursing assessments of the health status of individuals.” *A focused assessment* is an appraisal of an individual client’s status and situation at hand, contributing to comprehensive assessment by the registered nurse, supporting ongoing data collection, and deciding who needs to be informed of the information and when to inform. [217.11(3)(A)(i)] Registered nurses conduct “comprehensive nursing assessments of the health status of clients.” *A comprehensive nursing assessment* is an extensive data collection (initial and ongoing) for individuals, families, groups and communities addressing anticipated changes in client conditions as well as emergent changes in a client’s health status; recognizing alterations to previous client conditions; synthesizing the biological, psychological, spiritual and social aspects of the client’s condition; evaluating the impact of nursing care; and using this broad and complete analysis to make independent decisions and nursing diagnoses; plan nursing interventions, evaluate need for different interventions, and the need to communicate and consult with other health team members.

Additional Clarifications

Though not prescriptive to specific tasks, § 217.11 adopted by the Board establishes the outer parameters that the individual nurse at a given level of licensure may practice and still be “in compliance” with the rules, regardless of experience or practice setting. Because nursing at any level can involve “life and death” decisions, it is not prudent for a nurse to perform functions that require a higher level of licensure/authorization. This is often a difficult concept for non-nurses to grasp as they typically do not understand that there are limits as to how far a nurse may expand his/her scope within the same level of licensure. Additionally, non-nurses often fail to realize that a nurse always has a higher duty to his/her patient. Regardless of facility policies or physician orders, the nurse has a duty to maintain a safe environment for the client and others. Because of this duty, the Board holds each nurse accountable to accept only those assignments that are within the nurse’s education, experience, and knowledge, as well as the nurse’s physical and emotional abilities. While LVNs have always been able to expand their practice with continuing education, this concept of expansion has always had its limits. The NPA and §217.11 now serve in conjunction with the entry-level competencies (DELC) to provide guidance for consistency in LVN scope of practice, regardless of practice setting, or years of experience in vocational nursing or other healthcare-related field. Relative to the above concepts, the following statements provide additional clarifications for application of the NPA and §217.11 to vocational nursing practice:

- 1) LVNs cannot expand their practice to the level of a registered nurse through continuing education unless that education consists of a formal program of study and subsequent licensure by examination as a registered nurse. Practice within the independent scope of practice of a RN requires RN licensure.
- 2) If other laws require that a registered nurse perform a given task (such as “initial assessment”), said tasks cannot be assigned to the LVN under the RN’s (or any other licensed person’s) supervision.
- 3) Neither LVNs or RNs may perform tasks as “delegated medical acts” if the task requires the nurse to utilize independent medical judgment. Section 301.002 of the NPA precludes nurses from engaging in “medical diagnosis or prescription of therapeutic or corrective measures.” Also see Position Statement 15.11 (Delegated Medical Acts).
- 4) Prior to 2/1/04, LVNs were permitted to perform “first assistant” duties for a physician or surgeon under the delegation of the physician. The NPA became applicable to LVNs with the combining of the boards, and thus NPA sections 301.1525-301.1527 have precluded the performance of first assistant duties under medical delegation by LVNs since 2/1/04.

The table below and on page 14 offers a brief synopsis of how the scope of practice for nurses educated and licensed as vocational nurses differs from nurses educated and licensed as registered nurses. These are minimum competencies, but also set limits on what the LVN or RN can do at his/her given level of licensure, regardless of experience.

Memorandum of Understanding Established Between BNE and Texas Board of Pharmacy

The education nursing consultants for the Board of Nurse Examiners (BNE) have received many inquiries regarding the issue of student access to automated medical supply systems. In reviewing the Texas State Board of Pharmacy (TSBP) rules, it was found that Texas Pharmacy Rules limit access to automated medication supply systems in Class C pharmacies for stocking and retrieval of medications to licensed healthcare professionals or pharmacy technicians.

The Nursing Practice Act (NPA) requires that nurses, including nursing faculty, know and conform to the Texas NPA, BNE rules and regulations, as well as all federal, state, or local laws, rules and regulations affecting the nurse's current area of nursing practice. The NPA is not applicable to students when performing nursing duties incident to the program of study. To resolve the conflict, the BNE staff worked with the TSBP staff on creation of a Memorandum of Understanding (MOU) to allow nursing student access to automated medical supply systems. The MOU was presented to and approved by both the BNE and the TSBP.

The MOU specifies that automated medication supply systems (such as Pyxis, Sure Med, etc.) shall be available to nursing students acting under the supervision of a faculty/instructor and/or preceptor. The nursing program and the faculty should work with the healthcare facility and the pharmacists to develop a process that will facilitate providing access to nursing students. The MOU is applicable only to programs of study for the preparation of vocational nurses and registered nurses approved by the Board of Nurse Examiners and Class C pharmacies administering automated medication supply systems for retrieval of medications. The full text of the MOU appears below.

MEMORANDUM OF UNDERSTANDING Cooperative Agreement between Board of Nurse Examiners and Texas State Board of Pharmacy

WHEREAS, the Board of Nurse Examiners of Texas is the state agency with jurisdiction over the regulation of nursing practice of licensed vocational nurses and registered nurses and the approval of schools of nursing;

WHEREAS, the Board of Pharmacy of Texas is the state agency with jurisdiction over the regulation of pharmacists, pharmacy services and licensure of pharmacies;

WHEREAS, Section 301.002 (2) of the Texas Occupations Code defines "professional nursing" as involving the administration of a medication or treatment as ordered by a physician, podiatrist, or dentist;

WHEREAS, Section 301.002 (4) of the Texas Occupations Code defines "nursing" as including professional and vocational nursing;

WHEREAS, Section 560.051 (d) of the Texas Occupations Code allows that a Class C pharmacy license or institutional pharmacy license may be issued to a pharmacy located in an inpatient facility licensed under Chapter 241 or 577, Health and Safety Code; a hospital maintained or operated by the state; a hospice inpatient facility licensed under Chapter 142, Health and Safety Code; or an ambulatory surgical center licensed under Chapter 243, Health and Safety Code;

WHEREAS, Texas Pharmacy Rules, 22 Texas Administrative Code, Section 291.74 (j) (C) (i) (III), related to Operational Standards, limits the access to the automated medication supply system in a Class C pharmacy for stocking and retrieval of medications to licensed healthcare professionals or pharmacy technicians acting under the supervision of a licensed pharmacist;

WHEREAS, Board of Nurse Examiners' Rules and Regulations, 22 Texas Administrative Code, Chapters 211 and 231, require that the programs of study for the preparation of vocational nurses and registered nurses be designed to prepare graduates to practice according to the Standards of Nursing Practice, and designed and implemented to prepare students to demonstrate the essential entry level competencies, including the administration of medications and treatments as authorized by law and determined by the Board of Nurse Examiners;

WHEREAS, Board of Nurse Examiners' Rules and Regulations, 22 Texas Administrative Code, Chapters 211 and 231, also require that clinical nursing faculty and instructors in programs of study for the preparation of vocational nurses and registered nurses be licensed registered nurses or vocational nurses;

WHEREAS, students in programs of study for the preparation of vocational nurses and registered nurses as part of the program of study must be engaged, observed and supervised in direct patient care in the clinical health care setting which includes administration of medications and treatments as ordered by a physician, podiatrist, or dentist;

WHEREAS, Section 301.004 (6) of the Texas Occupations Code exempts students in programs of study for the preparation of vocational nurses and registered nurses from the requirement of holding a licensure when administering medications as an incident of the program of study;

WHEREAS, the Board of Nurse Examiners and the Texas State Board of Pharmacy believe that access to automated medication supply systems for retrieval of medications shall be available to students, in programs of study for the preparation of vocational nurses and registered nurses, acting under the supervision of a licensed healthcare professional clinical nursing faculty/instructor and/or preceptor of that nursing education program;

NOW THEREFORE, the Board of Nurse Examiners and the Texas State Board of Pharmacy agree that direct access to automated medication supply systems for retrieval of medications, administered by Class C pharmacies, shall be available to students in programs of study for the preparation of vocational nurses and registered nurses, acting under the supervision of a licensed healthcare professional clinical nursing faculty/instructor and/or preceptor of that nursing education program; and

This Memorandum of Understanding is applicable only to programs of study for the preparation of vocational nurses and registered nurses approved by the Board of Nurse Examiners and Class C pharmacies administering automated medication supply systems for retrieval of medications.

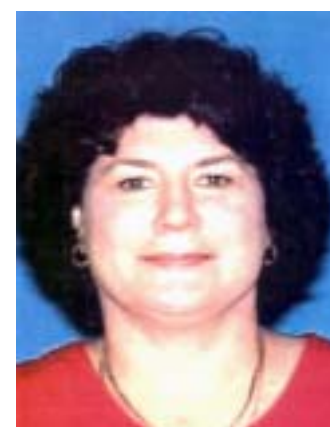
Deanna Allen

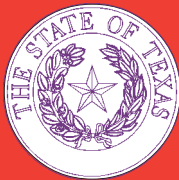
