The mission of the Texas Board of Nursing is to protect and promote the welfare of the people of Texas by ensuring that each person holding a license as a nurse in the State of Texas is competent to practice safely. The Board fulfills its mission through the regulation of the practice of nursing and the approval of nursing education programs. This mission, derived from the Nursing Practice Act, supersedes the interest of any individual, the nursing profession, or any special interest group.

Continuing Nursing Education Audit Procedure to Change This Summer

The Texas Board of Nursing (BON) is changing the process for continuing nursing education (CNE) audits. Beginning July 1, 2013, the BON will adopt a paperless system to receive documents related to continuing education audit requirements. The new system will allow the BON to evaluate CNE documents submitted by nurses for audit compliance, contact nurses by e-mail concerning deficiencies or questions relating to the CNE documents, and electronically notify nurses when all audit requirements have been met.

The BON will notify nurses selected for CNE audit by US mail twelve weeks prior to nurse license expiration. A toll-free telephone number will be established to assist individuals with questions about the audit process. All requested audit documents must be submitted by fax to the BON for processing.

All nurses with an active Texas license are required to demonstrate continuing competency through completion of courses eligible for CNE credit. In 1991, rules were adopted requiring nurses to complete 20 contact hours of CNE every two years for relicensure. CNE courses are defined as programs beyond the basic nursing preparation that are designed to promote and enrich knowledge, improve skills, and develop attitudes for the enhancement of nursing practice, thus improving health care to the public [22 TAC §216.1 (12)].

In 2009, rules were adopted to allow nurses to demonstrate competency through achievement of an approved national nursing certification in the nurse's area of practice *or* completion of 20 contact hours of CNE. In 2010, rule changes required contact hours to be in the nurse's area of practice.

The BON conducts random audits of nurses renewing their licenses each month. Individuals selected for CNE audit will submit their audit documents by fax or mail. Currently, BON staff responsible for CNE audits must sort through a wide range of correspondence faxed and mailed to the agency in order to locate CNE audit specific documents. Audit documents are evaluated for CNE compliance and, upon audit completion, stored on-site, per agency record-retention requirements.

The CNE audit process change is one facet of the BON strategy toward paperless licensure, that will improve the efficiency of the licensing process, and increase the speed in which a nursing license is obtained. The BON will post further information concerning the CNE audit process on the BON website, www.bon.texas.gov, at a later date.

Nurse Employers Adopting NURSYS E-Notify System

Nursys e-Notify, the national nurse licensure notification system launched in January by the National Council of State Boards of Nursing (NCSBN), that automatically delivers licensure and publicly available discipline data directly to employers as the data is entered into the Nursys database by United States boards of nursing (BONs) has been adopted by more than 150 nurse employers in Texas.

Nursys is the only national database for verification of nurse licensure, discipline, and practice privileges for registered nurses (RNs) and licensed practical/vocational nurses (LPN/VNs). It is comprised of data obtained directly from the licensure systems of U.S. BONs through frequent, secured updates.

Summary of Actions

A regular meeting of the Board of Nursing was held January 17-18, 2013, in Austin. The following is a summary of Board actions taken during this meeting.



On February 15, 2013, the Board proposed amendments to 22 Tex. Admin. Code sections 211.7 (relating to the ability of the Executive Director to grant requests for exceptions to prior Board Orders and negotiate limited licenses and return to direct patient care) and 220.2 (relating to the Nurse Licensure Compact). The comment period ended on March 18, 2013. No comments were received. The rules are scheduled to be adopted by the Board in April.

APRNs and Pain Management

In recent years, much attention has been given to treatment of patients who are experiencing pain associated with a disease process or condition. There is a body of literature that describes how pain is often under-treated by health care providers, and findings urge providers to work with their patients to help them manage their pain. At the same time, there has been a tremendous increase in the number of cases of prescription drug diversion and abuse. These parallel trends can present challenges for advanced practice registered nurses (APRNs) who work with patients experiencing pain.

APRNs who practice in pain management settings must be aware that Chapter 168 of the Texas Occupations *Code* requires pain management clinics to be registered with the Texas Medical Board. Although there are exemptions from registration for APRN-owned or operated clinics in which the APRN treats patients in his/her area of specialty and uses other forms of treatment with the issuance of a prescription for the majority of the patients, this statement does not mean that an APRN may own a pain management clinic. Only physicians may own pain management clinics, and physician owners/ operators must be on site 33% of the time and review 33% of all patient files. This is more than is normally required for delegation of prescriptive authority in any other type of practice site. Texas Medical Board Rule 195.4 further clarifies that, in the case of the exemption for the APRN-owned or operated clinic, the APRN must personally provide the other forms of

treatment of the patient's condition. In other words, if the other forms of treatment are not personally provided by the APRN, the clinic must be registered as a pain management clinic and comply with all requirements for such clinics set forth by the Texas Medical Board.

It is also important that APRNs who provide pain management services safeguard their patients by ensuring that they meet the standard of care with regard to treatment of pain. Collecting and documenting a thorough and careful history, as well as completion of a comprehensive physical assessment, will provide significant information to assist the APRN. The risk for abuse or diversion must be part of the assessment for all patients, not just those who have a history of substance abuse. This evaluation may include the Texas Department of Public Safety's Prescription Access in Texas program in which authorized users may access the last 365 days of an individual patient's prescription history.

A treatment plan should be developed that clearly identifies the goals of treatment and also provides for periodic review of the plan. Written informed consent and agreement to comply with the treatment plan, as well as any consultation and referral requests, should be included in the medical record. Clear and accurate documentation is essential. In addition to the history, assessment, and treatment plan, it is also important to clearly document patient education and plans



for follow-up and monitoring. When prescriptions for controlled substances are issued, it is important for APRNs to remember that they must comply with Texas law. APRNs may only issue prescriptions for controlled substances in Schedules III through V. Likewise, they may only issue a prescription, including a refill of a prescription, for a period that does not exceed 90 days. Beyond the 90 day period, the APRN must consult with the collaborating physician and document that consultation in the patient's medical record.

APRNs who provide pain management services must work to maintain a balance between compassionate relief of suffering and appropriate levels of vigilance related to prescribing of medications. Achieving this balance is necessary to ensure patient safety while providing quality advanced practice nursing care.

Position Statements with Substantive Changes

A Brief Overview

In January of each year the Texas Board of Nursing (Board) reviews Board Position Statements for accuracy and relevance to ensure appropriate guidance related to nursing education and practice. This year several of the Position Statements had substantive changes. Each of the Position Statements are provided below with a brief overview of the substantive changes that were adopted by the Board.

Position Statement 15.2, The Role of the Licensed Vocational Nurse in the Pronouncement of Death has generated the question "may the LVN contact a funeral home?" While it is not within the LVN scope of practice to pronounce death, there are many tasks that the LVN may perform once a person is deceased. The additional task of contacting a funeral home was added to the list of examples in the Position Statement to provide further information and clarification for LVNs and the public.

Position Statement 15.8, The Role of the Nurse in Moderate Sedation. has been the topic of numerous calls and emails to Board staff. Many nurses have had questions regarding whether the RN should be the one to administer an anesthetic agent even when a CRNA or anesthesiologist is present. To address this question, a new explanation was added to clarify that the RN may administer the anesthetic agent if the patient's airway is appropriately managed. Another source of confusion, especially in the emergency department, was whether an RN could administer anesthetic agents when a physician was present who had intubation skills and could abandon the procedure to intubate the patient. This clarification was added to the Position Statement.

Position Statement 15.13, Role of LVNs and RNs as School Nurses has substantive changes regarding the role of the LVN as a school nurse. Revisions emphasize that the LVN's scope of practice is directed and supervised by an appropriate supervisor such as an RN. Changes to the RN delegation section of the Position Statement reflect the work and recommendations from the 2011 Delegation Task Force for Chapter 225.

Position Statement 15.15, Board's Jurisdiction over a Nurse's Practice in Any Role and Use of the Nursing **Title** is often referenced and contains several substantive changes including a new title. The former title, Board's Jurisdiction over Nursing Titles and Practice, did not represent the topic of the Position Statement and led to difficulty locating the information. Content within the Position Statement was changed to reflect Board decisions in 2012. One content area relates to questions from RNs wanting to know if the RN can accept an LVN position and use the LVN title. This issue was addressed by adding clarifying language to reflect that each nursing title is protected and may only be used by an appropriately licensed nurse. The phrase "practice setting" was updated to "area of practice" as the later phrase is defined in Board rules and explained in a frequently asked question.

All Position Statements are accessible on the Board website in the *Nursing Practice* section. Many of the Position Statements contain references to the Nursing Practice Act and Board Rules, also accessible on the Board website in the *Nursing Law and Rules* section, and provide information to nurses, nursing employers, and others regarding various aspects of nursing practice.

BON to Discontinue Issuance of Paper Letters for APRN Interim Approval and Prescriptive Authority

In order to expedite the licensing process, the Texas Board of Nursing (Board or BON) will discontinue mailing approval letters to advanced practice registered nurses (APRNs), when interim approval and prescriptive authority are granted. This change will become effective on September 1, 2013. Interim approval and prescriptive authority approval can be verified on the Board's website twenty-four hours a day, seven days a week. The BON website is the primary source for this type of verification.

APRNs and their employers may choose to print and retain a copy of interim approval and prescriptive authority approval directly from the Board's website. To access this information, click on Verification and Licensing, then Advanced Practice Recognition for Registered Nurses. Nurses with a Texas RN license may use their Texas RN License number to access interim approval (temporary authorization to practice) or prescriptive authority approval. Nurses practicing in Texas on a multi-state registration should use the last four digits of their social security numbers and their birthdates to verify interim approval (temporary authorization to practice) or prescriptive authority approval. Texas RNs receiving advanced practice licensure will still receive a certificate in the mail when full licensure is granted to practice as advanced practice registered nurses.

Verification of interim approval and prescriptive authority approval may also be completed by phone, Monday through Friday, 8:00 am to 5:00 pm, Central Standard Time, by contacting the Customer Service Department of the BON at (512) 305-7400. When Do Nurses Have a Duty to Report Confidential Health Information?

In January 2013, the U.S. Department of Health and Human Services - Office for Civil Rights issued clarification regarding the Health Insurance Portability and Accountability Act (HIPAA) titled, *Message to Our Nation's Health Care Providers*. The message can be found at http://www.hhs.gov/ocr/office/lettertonationhcp.pdf.

Nurses have a duty to report patient information, including mental health information, to members of law enforcement, a patient's family and others when a patient is a serious danger to himself or others. The confidentiality rule, also known as HIPAA, does not prevent nurses who act in "good faith" from reporting necessary information about a patient to those who may be able to prevent or lessen a danger to a patient or the public. The confidentiality rule is balanced to protect a patient's health information while allowing information to be disclosed that could protect both the public and a patient from harm.

The Texas Board of Nursing has developed standards of nursing practice that apply to nurses' duty to report confidential health information and require licensed vocational nurses, registered nurses and advanced practice registered nurses to: understand and follow the laws applicable to their area of practice; provide a safe environment for a patient and others; and respect a patient's right to confidentiality and disclose information to the proper authorities when necessary to protect a patient and the public from harm. Message to Our Nation's Health Care Providers:

In light of recent tragic and horrific events in our nation, including the mass shootings in Newtown, CT, and Aurora, CO, I wanted to take this opportunity to ensure that you are aware that the Health Insurance Portability and Accountability Act (HIPAA) Privacy Rule does not prevent your ability to disclose necessary information about a patient to law enforcement, family members of the patient, or other persons, when you believe the patient presents a serious danger to himself or other people.

The HIPAA Privacy Rule protects the privacy of patients' health information but is balanced to ensure that appropriate uses and disclosures of the information still may be made when necessary to treat a patient, to protect the nation's public health, and for other critical purposes, such as when a provider seeks to warn or report that persons may be at risk of harm because of a patient. When a health care provider believes in good faith that such a warning is necessary to prevent or lessen a serious and imminent threat to the health or safety of the patient or others, the Privacy Rule allows the provider, consistent with applicable law and standards of ethical conduct, to alert those persons whom the provider believes are reasonably able to prevent or lessen the threat. Further, the provider is presumed to have had a good faith belief when his or her belief is based upon the provider's actual knowledge (i.e., based on the provider's own interaction with the patient) or in reliance on a credible representation by a person with apparent knowledge or authority (i.e., based on a credible report from a family member of the patient or other person). These provisions may be found in the Privacy Rule at 45 CFR § 164.512(j).

Under these provisions, a health care provider may disclose patient information, including information from mental health records, if necessary, to law enforcement, family members of the patient, or any other persons who may reasonably be able to prevent or lessen the risk of harm. For example, if a mental health professional has a patient who has made a credible threat to inflict serious and imminent bodily harm on one or more persons, HIPAA permits the mental health professional to alert the police, a parent or other family member, school administrators or campus police, and others who may be able to intervene to avert harm from the threat.

In addition to professional ethical standards, most states have laws and/or court decisions which address, and in many instances require, disclosure of patient information to prevent or lessen the risk of harm. Providers should consult the laws applicable to their profession in the states where they practice, as well as 42 CFR Part 2 under federal law (governing the disclosure of substance abuse treatment records) to understand their duties and authority in situations where they have information indicating a threat to public safety.

We at the Office for Civil Rights understand that health care providers may at times have information about a patient that indicates a serious and imminent threat to health or safety. At those times, providers play an important role in protecting the safety of their patients and the broader community. I hope this letter is helpful in making clear that the HIPAA Privacy Rule does not prevent providers from sharing this information to fulfill their legal and ethical duties to warn or as otherwise necessary to prevent or lessen the risk of harm, consistent with applicable law and ethical standards.

The case was referred to the Ector County Attorney's Office, Odessa, Texas, and to the Crane County District Attorney's Office, Odessa, Texas.
